Dear Board Members and Ms. Prezioso:

Bowles Rice LLP is bond counsel for New Creek Public Service District (the "District") with respect to the above-referenced sewer project (the "Project"). The purpose of this letter is to request the approval of the Board of the West Virginia Water Development Authority to a reduction in the number of customers to be served by the Project, as required by West Virginia Code 22C-1-5(5), from approximately 100 as set forth in the Engineer Preliminary Application Form submitted to the West Virginia Infrastructure and Jobs Development Council (the "WVIJDC") on August 6, 2021 (the "Engineer Preliminary Application Form"), to approximately 75 new customers as set forth in the correspondence included in Appendix A attached hereto. The Appendix A attached to this letter includes the correspondence from Region 8 Planning and Development Council, the Administrator for the Project, and from John W. Cole, PE, with RK&K, the engineer for the Project, to Wayne Morgan, PE, Executive Director of the WVIJDC), providing detailed information on the changes in scope, cost estimates and proposed sources of funding for the Project.

The Engineer Preliminary Application Form submitted to the WVIJDC stated that the District is pursuing the Project to rehabilitate the District's sewer collection system (the "System") to reduce the amount of inflow and infiltration entering the System along with expanding the existing System to serve approximately 100 new residential customers. As set forth in the letter from RK&K dated March 9, 2023, to Mr. Wayne Morgan, PE, included in Appendix A, the District determined that changes were necessary to the scope of the Project as described in the Engineer Preliminary Application Form including without limitation the reduction in the number of new homes to be served from approximately 100 to approximately 75. As further set forth in such letter, the overall scope of the Project needed to be scaled back due to increased costs due to a number of factors including the costs of materials and equipment. The WVIJDC approved the District's request with respect to the

changes in scope, costs and sources of funding in the letter from the WVIJDC dated April 7, 2023, a copy of which letter is included in Appendix B attached hereto.

Attached as Appendix C is a copy of the letter from John W. Cole, PE, with RK&K, the Project engineer, to the undersigned. It includes as an attachment the letter from the City of Keyser to the District dated January 22, 2022, regarding the urgency of addressing the inflow and infiltration problem. As further set forth in such letter from Mr. Cole, since the approval of the reduction in the number of new customers by the WVIJDC, the District has been focused on completing the current Project before extending the System to additional customers. Mr. Cole further states in his letter that "[a]s identified within the District's Facility Plan, several sewer line extensions are planned for extending public sewer to currently unserved areas, and the current project was just the initial area of focus. As a result, the District will evaluate the most efficient and economic approach for serving these 25 customers, in addition to the other areas of focus, as part of a future project. Timing for the future project has not been established, however, concerns expressed by the City of Keyser (City) over the amount of I&I entering the City's sewer system will need to be addressed before any additional customers are connected."

The final cost and sources of funding for the Project were approved by the WVIJDC as set forth in the letter from the WVIJDC to the District dated March 6, 2024, a copy of which is included in Appendix D attached hereto.

The approval of the Board of the West Virginia Water Development Authority is respectfully requested by the District to the removal of 25 customers from the Project resulting in the total of new customers to be at least 75. This will allow the District to move forward with the Project to address the inflow and infiltration issue, serve at least 75 new customers and ensure the commitment of ARPA and EEG funds within the required time frames.

On behalf of the New Creek Public Service District (District), please allow this letter to serve as a formal request for a change in project scope and proposed funding for the project.

Since the initial IJDC Application, the District determined that changes were necessary to the overall project scope during the design phase. Instead of extending sewer service to the 100 homes identified in the application, the revised project will serve approximately 75 homes within the Great Oak Valley Subdivision, Hickory Knoll Road, and along Pine Swamp Road, several of which are experiencing failing septic systems with surface discharges. The remaining 25 homes not included in this project will be included in a future sewer line extension project submitted as part of a separate application.

The resulting changes also modify the initial funding requested as part of the application. The current cost estimate of the revised project is estimated at \$7,421,000, as summarized in the enclosed cost estimate and revised IJDC General Budget summary. Although the overall scope of the project has been scaled back, the cost of the project has increased due to a number of factors including the costs of materials and equipment. To cover the estimated cost of the revised project, specifically the increase above the October 19, 2021 funding recommendation, the District is proposing to request WDA Economic Enhancement Grant Funds (WDA EEGF). Overall, the below identifies the revised funding scenario:

- CWSRF Principal Forgiveness \$1,000,000.00
- CWSRF Loan (0.5%, 40yr) \$2,296,800.00
- WV IJDC Grant \$1,000,000.00
- Mineral County ARPA \$300,000.00
- USDA Grant \$1,000,000.00
- USDA Loan (2.25%, 38 yr.) \$340,000.00
- WDA EEGF \$1,484,200.00

A revised Draft Schedule B identifying the allocation of the proposed funding is also enclosed.

Currently, RK&K is working with the District on finalizing the design with the next step involving obtaining the necessary easements and property acquisition. Overall, the District desires to position themselves to advertise the project for construction in late summer of 2023.

Since approval to the reduction in the number of new customers, the District has been focused on completing the current project before focusing on extending service to additional customers. As identified within the District's Facility Plan, several sewer line extensions are planned for extending public sewer to currently unserved areas, and the current project was just the initial area of focus. As a result, the District will evaluate the most efficient and economic approach for serving these 25 customers, in addition to the other areas of focus, as part of a future project.

Timing for the future project has not been established, however, concerns expressed by the City of Keyser (City) over the amount of I&I entering the City's sewer system will need to be addressed before any additional customers are connected. Enclosed is a copy of the City's January 22, 2022 letter which mentions multiple sewer backups into residents' homes due to the amount of I&I entering the system. Fortunately, the District's current project includes rehabilitation efforts for reducing the amount of I&I the District is contributing to the situation. The City also references that they are working on rehabilitation efforts to reduce the amount of I&I within their system. Ultimately, the success of the District's current project at reducing the amount I&I entering the City's sewer system will determine the timing of any future project.

The Huntington Sanitary Board (HSB) submitted a funding application to the West Virginia Infrastructure Jobs Development Council (WVIJDC) on January 10, 2023 to extend sanitary sewer service along Route 10 to the Green Valley Heights subdivision. The funding application was for a multi-phase project to serve a total of 600 customers in the project area. The Phase 1 project as outlined in the application proposed to serve 467 customers. On behalf of North Beckley Public Service District (PSD) please note the request for customer service change for the Piney View/Batoff Mountain Sewerline Extension Project. Due to increased pre-bid cost estimates and to help facilitate making the under construction by December 30, 2024 WV Water Development Authority Economic Enhancement Grant (EEG) Fund requirement the PSD proposed splitting the project into two parts. This bifurcation of the project is along existing construction contract one serving Piney View and contract two serving Stonewall Road. Of the 218 customers in the entirely grant funded project 121 are in Piney View and ninety-seven (97) are along Stonewall Road. Under the proposal, recommended by WV IJDC Funding and Technical Review Committee the PSD would complete contract one now with existing funds and seek funding for contract two in the future.

The PSD and the Raleigh County Commission have worked diligently to progress Right of Way and acquisition collections to attempt to meet the required EEG timeline. While there has been significant progress made on the collection easements and acquisitions 137 of 189 total project easements and six (6) of eight (8) total acquisitions have been obtained. Of this the project attorney has prepared up to eleven (11) easement condemnations and one (1) acquisition condemnation for contract one for filing August 2, 2024 to be able to issue a Final Title Opinion on contract one once the NPDES Stormwater Permit is issued.

The PSD respectfully requests WV Water Development Authority approval to reduce the customer count of 218 to 121 to serve part one Piney View area and serve the remaining ninety-seven (97) customers on Stonewall Road at a later date upon funding availability.

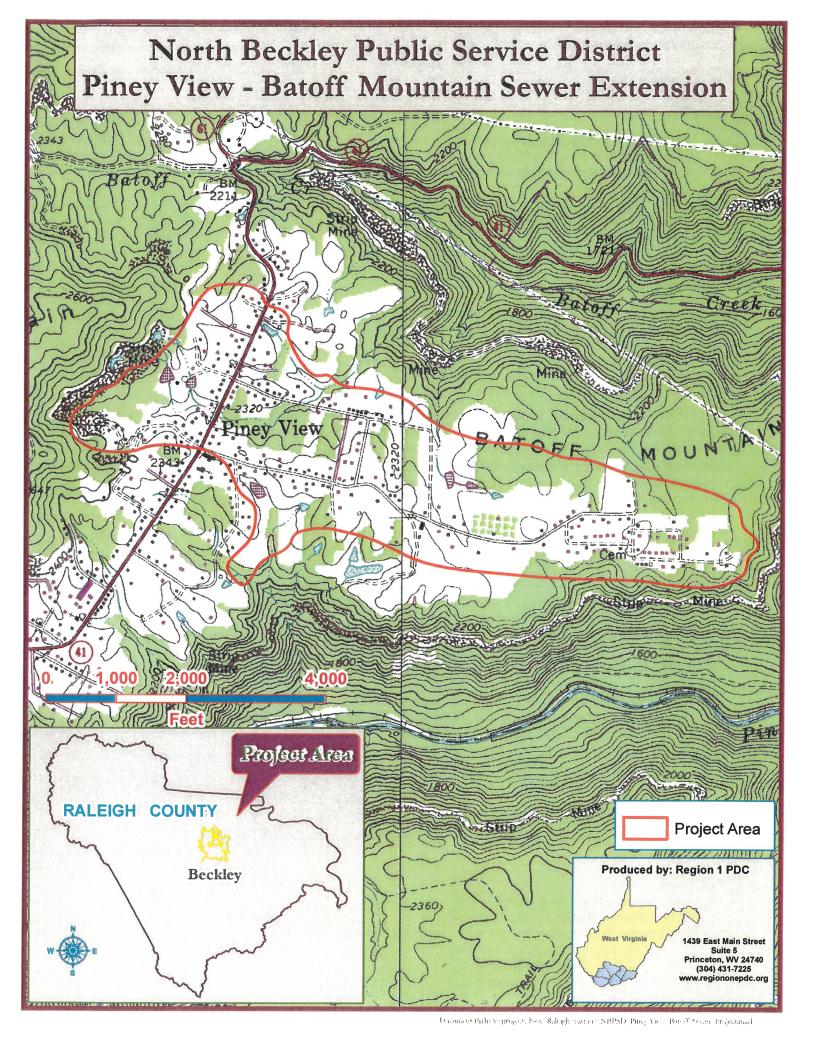

2) Project Description

Scope:

On September 14, 2022, the West Virginia Health Care Authority (HCA) granted the request by the Mon Health Marion Neighborhood Hospital, Inc. (Mon Marion), to construct a 19,000 square foot, 10-bed small format hospital in Harrison County, West Virginia. In addition, on May 16, 2024, the HCA granted further approval to add an additional 19,000 square feet to the proposed hospital's footprint, essentially doubling the size by adding a second floor to the building. The new hospital will be a part or a division of Mon Marion, not a separate legal entity, but will do business as the Mon Health Harrison Neighborhood Hospital (Mon Harrison).

The hospital will be built on three acres of property located at 770 Haden Boulevard, Bridgeport, West Virginia, 26330. Adjacent to these three acres, the hospital owns seventeen additional acres on which will be built offices for additional providers. The campus in total will encompass twenty acres, a new hospital and associated office buildings. The new hospital will provide inpatient services in a 10-bed inpatient facility, emergency services with 8 emergency room beds and the related support services including on-site x-ray, CT, ultrasound, and laboratory services.

The proposed service area is Harrison County, West Virginia, focused primarily on the residents of nearby Bridgeport and Clarksburg, West Virginia, and surrounding counties. The objective of the project is to bring accessible, high quality, cost effective caring services to residents of Harrison County. Studies and recent operating results of similar small format hospitals show that these facilities are perfectly designed to provide cost-effective, high-quality health care services to communities like these. This new facility will help alleviate unnecessary wait times for emergency services and provide a low-cost alternative to the existing hospital in Harrison County. The purpose of Mon Harrison is to provide services to patients closer to home and to decompress high utilized ED services at United Hospital Center. Clearly put, the objective of this project is "to provide quality healthcare services to the right patients, at the right place, at the right costs." This project provides an alternative to the large campus hospitals that have become less and less efficient and cost-effective.

Budget and Sources of Funding:

The Project's proposed budget is twenty-four million seven hundred fifty thousand dollars (\$24,750,000) and the request to this West Virginia Development Authority's Economic Enhancement Grant Funding is to fund ten million dollars (\$10,000,000) of the total budget. The remaining fourteen million seven hundred fifty thousand dollars (\$14,750,000) will be attained through both internal and external corporate financing, as well as charitable and philanthropic donations. The financial feasibility and other related analysis for the Project were completed by Baker Tilly. The project is financially feasible.

Glenville State University School of Health Sciences MKA #22033.01 Architectural Programming

General

Glenville State University would like to start a College of Health Sciences, comprised of Nursing, Athletic Training, Exercise Physiology, and Physical Therapy. All disciplines are new offerings at the University, except Exercise Physiology. There will be about 25-30 students in each discipline, and 12 faculty members to oversee the college with assistance from Marshall University.

On the first floor of wing 'A' at the Waco Center (Figure 1), the University has targeted approximately 6,500 square feet of unbuilt space for the College of Health Sciences (Figures 2 & 3). This interior fit-out will consist of laboratory spaces for lecture with advanced technology and simulation, support spaces, a collaboration/lounge space, and faculty offices (Program of Spaces document). The College of Health Sciences will share the classrooms, lecture spaces and library space with the School of Land Resources, which currently resides on the second floor (Figure 4v& 5). The goal of the University is to draw students with the College of Health Sciences and retain young professionals in its geographical area for the growing healthcare sector.

Conceptual Space Usage

A conceptual program has been included based on preliminary discussions and our review of the necessary requirement. Space allocations require further review and discussion, priorities of GSU, and available buildable area. As such modification to this preliminary program is expected. As indicated in attached Space Utilization Plan, one possible arrangement in implementing this program is to provide a Skills Lab and a Simulation Lab with an adjoining Lecture Room which would incorporate stations similar to Marshall University existing Labs (Figures 6 & 7) for the College's Nursing program. A large open Lab is envisioned for optimal flexibility to be utilized by the Athletic Training, Exercise Physiology and Physical Therapy programs. As a result of all Labs being very equipment laden. Storage space is adjacent to each Lab. Upon entering the College of Health Sciences there is Lounge space to relax, study and collaborate between classes. There may be the potential for faculty cubicles on the first floor to be moved to the second floor into shared offices or new office space that can be retrofitted into existing storage along a corridor. This would allow for additional support space for the Labs on the first floor. The potential space usage shown and discussed above are very much preliminary and will be subject to much revision in design meetings with GSU to align with program goals, objectives, and available resources.



Conceptual Project Costs

At this very early stage, estimating probable project costs are very much an opinion, but based on our knowledge and experience we have provided the attached preliminary budget. This document is based on the area of renovations being considered and what we anticipate are reasonable cost allowances for the various construction related costs. This too is subject to much discussion and update as we further identify specific needs for equipment, MEP Systems, desired finishes, and market conditions. We have included reasonable allowances for variances in the estimate of probable cost. Also included is an estimate of an FF&E package to outfit the new Laboratory Spaces provided by Dr. Sandra Hodges, Lab Coordinator at Marshall University.

Conceptual Project Visualization

To take conceptual project a step further we have also attached renderings based on the preliminary program. The renderings illustrate the plan, Labs, Lounge and Exterior Entry. Also attached is a color board and schedule of proposed finishes to pull together the initial preliminary project concept.

WV Regional Tech Park and Jefferson Park Project Description City of South Charleston

May 9, 2024

The City of South Charleston has undertaken the redevelopment of an older residential neighborhood known as Jefferson Park. The site is 23.5-acres, and the future higher and best use of the property would be commercial development. The site is situated in the Park Place Economic Opportunity Development District. South Charleston has invested more than \$53,000,000.00 on the site development in the district, including \$12,000,000.00 in property acquisition of 85 houses in Jefferson Park. The West Virginia Regional Technology Park (WVRTP) is also included in the district and development projects so far have created a pad ready 14-acre site available for the construction of the State of West Virginia Consolidated Laboratories. An additional project is proposed below that will create another 12-acre pad ready site in the WVRTP.

The Jefferson Park Development Site has direct access to the new Jefferson Road connector between MacCorkle Ave. (US 60) and Corridor G (US 119). The site is located in a flood zone and will require 350,000 cubic yards of fill material to bring the site elevation to a minimum of 2 feet above the base flood elevation. The WV Consolidated Labs will require an additional 50,000 cubic yards of material to expand the footprint of the planned parking lot. There is a location in the WVRTP that can be used as a borrow area and would produce 600,000 cubic yards of fill and leave a 12-acre pad ready site. (See exhibit A: Conceptual Plan WVRTP)

As a phase two project, the State Police Headquarters (WVSP) is located on the west side of Jefferson Road across from the Jefferson Park site. The South Charleston Community Center is located adjacent to the WVSP site and together along with a strip of flood prone vacant land owned by Kenna Homes creates another 22.5 acres of commercial development property. To make this site pad ready for development will require 200,000 cubic yards of fill, which would increase the size of the developable acreage at the Tech Park borrow area, if the WVSP were relocated once the WVSP labs are relocated to the State Consolidated Lab space.

There is very serious interest in investments by national firms in commercial development at these sites and together they will generate large tax revenues, private investments, and full-time employment. It is projected that the full development at the two sites would result in a private investment of more than \$50,000,000.00 in new construction, and 500 FTE jobs.

South Charleston is requesting \$8,000,000.00 in Economic Enhancement Grant Funding to complete the site development for these important projects. The engineering and regulatory review of these projects indicate no major issues and can be completed with standard construction methods.

Monday Lick Trail Project

In 2019 the International Mountain Bicycling Association (IMBA) recognized the Snowshoe Highlands Area Recreational Collaborative's (SHARC) Snowshoe Highlands Ride Center with an award of a bronze-level designation, followed by a promotion to the silver level in 2020. In the years since, SHARC and its partners across the region have united behind a singular goal: to become the first gold-level Ride Center in the eastern U.S. by 2025.

Ride Center designations are hard to come by. There are currently 40 Ride Centers across the world, including only six at the gold level. By joining their ranks, Snowshoe Highlands would be recognized as one of the top seven mountain bike destinations in the world, placing Pocahontas County and the Monongahela National Forest on the international stage for outdoor recreation.

Committed to this goal, SHARC has worked in concert with IMBA to conduct a gap analysis to identify needs and implement a strategic plan that will lead to gold-level Ride Center certification by 2025. In early 2022, IMBA Trail Solutions released an updated assessment report for the Snowshoe Highlands Ride Center. This report establishes the following final priority trail enhancements SHARC must complete to secure gold for the Ride Center:

- 1. Construct the Monday Lick Trail System in Marlinton.
- 2. Maintain and enhance the Tea Creek Trail System.
- 3. Complete the trail connection between Mower Tract and Snowshoe

The Monday Lick Trail Project (1) consists of the construction of a 27-mile trail system in the Monongahela National Forest near the Town of Marlinton in Pocahontas County. In September 2022, Region 4 Planning and Development Council was awarded a \$1,500,000.00 Appalachian Regional Commission (ARC) Partnerships for Opportunity and Workforce Economic Revitalization (POWER) grant for the construction of the trail along with a \$160,000.00 Benedum Foundation grant to support administration and trail positions to complete the Tea Creek Trail System (2) and the connector between the Mower Tract and Snowshoe (3).

Additionally, the Snowshoe Resort has pledged a \$2,000,000.00 cash match for continued maintenance and capital improvements to the overall trail system over the next 5-years. The U.S. Forest Service has committed \$1,004,340.00 towards National Environmental Protection Act (NEPA) compliance, procurement, project management, construction oversight and to support the additional trailing building and maintenance efforts. Lastly, the Pocahontas County Convention and Visitor's Bureau has committed \$6,000.00 in in-kind match for staff time dedicated to the project for a total project cost of \$4,670,340.00.

The project is actively under construction, but due to the strain of inflation across all facets of construction, the project is in need of an additional \$175,000.00 to complete the last 2.4 miles of the Monday Lick Trail. Please find attached the current Schedule B along with a construction cost estimate. A project timeline is also attached:

Project Construction Schedule

Overview:

Construction of Monday Lick began in the fall of 2023 and has completed approximately 12.3 miles of trail construction as of this week. There are 14.2 miles of trail under contract and in the construction phase. A total of 27.3 miles will be completed by the end of this fall 2024 season. The remaining 2.4 miles are not funded at this time.

Details- please see excel attachment for exact dollar figures.

- Construction started in Fall 2023 with one contract (task order) awarded for 4 miles (2 trails). That contract and trails are completed.
- In Spring 24 another contract was issued for 6.5 miles (3 trails). That contract and trails are completed.
- In early summer a contact to a <u>second</u> contractor was issued for 13 miles (5 trails) in which 5.8 miles are completed.
- Another contract was issued this summer for .8 miles for one trail.

Construction Estimated to be Complete:

There is currently \$35,913.75 remaining in the ARC Grant.

WHEREAS, the Authority maintains and will maintain a sub account for each current and future appropriation and has and will track the earnings on each sub account;

WHEREAS, the Authority has and will identify the sub account source of funding when making awards from the EEGF for eligible projects under the Act;

WHEREAS, the \$427,000,000 of appropriations must be under contract for eligible costs by December 31, 2024 or be refunded to the United States Treasury; and

WHEREAS, it is in the best interest of the State and its citizens for the Authority to have the ability and flexibility to redesignate the sub account source so that required EEGF funds can be under contract by December 31, 2024 or to expedite project funding.

NOW, THEREFORE, BE IT RESOLVED BY THE WATER DEVELOPMENT BOARD OF THE AUTHORITY AS FOLLOWS:

Section 1. The Executive Director, in consultation with the Chair, may redesignate any current or future appropriations to the EEGF, if such redesignation allows specific project funding to be under contract prior to December 31, 2024 or such funding to be spent more efficiently.

Section 2. This Resolution shall be effective immediately upon adoption.
